關於建築地盤(安全)規例內建築工程的呈報

I. 建築工程的動工

根據建築地盤(安全)規例第 56條的規定,承建商須在建築工程展開後 7天內,以書面向勞工處處長提供以下資料:

- (a) 承建商的姓名或名稱及地址;
- (b) 如承建商是一間商號,則提供該商號營業所用的名稱以及該商號每名合夥人的姓名或 名稱及地址;
- (c) 受聘進行建築工程的每名次承建商的姓名或名稱及地址;
- (d) 建築地盤的位置;
- (e) 建築工程的性質;
- (f) 建築工程展開的日期;
- (g) 說明有否或會否在建築工程方面使用任何機械動力,如有使用或會使用,說明該機械動力的性質;及
- (h) 建築工程的預計持續期。

II. 資料改變的呈報

根據建築地盤(安全)規例第58條的規定,進行有關建築工程的承建商須在得悉呈報的資料有重要改變後7天內,以書面向勞工處處長呈報該項改變。

III. 完工的呈報

根據建築地盤(安全)規例地第 59 條的規定,須提供資料的承建商須在有關建築工程完成後7天內,以書面向勞工處處長呈報完工日期。

何爲建築工程?

"建築工程"指一

- (a) 建造、架設、安裝、重建、修葺、維修(包括重新修飾及外圍清理)、翻新、遷移、改動、改善、拆除或拆卸工廠及工業經營條例附表 3 所指明的任何構築物或工程;
- (b) 為預備進行(a)段所提述的工程行動而涉及的任何工程,包括鋪築地基和鋪築地基前的 挖掘泥土及沙石工程;
- (c) 爲進行(a)或(b)段所提述的任何工程行動而使用機械、工業裝置、工具、裝置及物料。

Guide to Form Users

Notification of construction work under the Construction Sites (Safety) Regulations

I. Commencement of Work

A contractor who undertakes construction work shall, in accordance with Regulation 56, within 7 days after the commencement of the work, furnish in writing to the Commissioner for Labour the following information-

(a) the contractor's name and address;

- (b) if the contractor is a firm, the name under which it carries on business and the name and address of every partner in the firm;
- (c) the name and address of every subcontractor employed on the work;
- (d) the location of the construction site;
- (e) the nature of the work;

(f) the date upon which the work was commenced;

- (g) whether any mechanical power is being or will be used in connection with the work and, if so, the nature of the mechanical power; and
- (h) the expected duration of the work.

II. Notification of Change

The contractor undertaking the relevant construction work shall, in accordance with Regulation 58, notify the Commissioner for Labour in writing of any material change in the information furnished within 7 days after becoming aware of the change.

III. Notification of Completion

The contractor required to furnish information under Regulation 56 shall, in accordance with Regulation 59, within 7 days after the date of completion of the relevant construction work, notify the Commissioner for Labour in writing of the date of completion.

What is construction work?

"construction work" means-

- (a) the construction, erection, installation, reconstruction, repair, maintenance (including redecoration and external cleaning), renewal, removal, alteration, improvement, dismantling, or demolition of any structure or works specified in the Third Schedule of the Factories and Industrial Undertakings Ordinance;
- (b) any work involved in preparing for any operation referred to in paragraph (a), including the laying of foundations and the excavation of earth and rock prior to the laying of foundations;
- (c) the use of machinery, plant, tools, gear, and materials in connexion with any operation referred to in paragraph (a) or (b).

Submission of the Form

You can submit the notification form either:
